## **Responsibilities**

Work closely with BCMAC leaders, with support from Breathe Project collaborative members

- Initiate accountability-related information gathering, synthesis and communication
- Gather information on current and past instances of community emergency response in order to improve accountability/transparency/responsiveness
- Generate useful reports on key findings and recommendations
- Share key findings with the community and its leaders

Build capacity for community air quality monitoring

• Help grow a Citizen Air Monitoring Network

Enhance community engagement

- Expand network of social media followers
- Inspire supporters/followers into engagement
- Grow a broader coalition by recruiting youth, people of color and labor into the network
- Build capacity/team for conducting community canvasses and surveys. Work with BCMAC to identify tools for strengthening community ties.

Support related community campaign activities

- Serve as a liaison with the ReImagine Beaver County Downstream Strategies Initiative
- Assist with the development of citizen teams to advocate for protective ordinances in municipalities

Examples of Specific Job Activities

- Facebook engagement: increase frequency and depth of social media posts
- Develop a team of young and diverse hourly-wage phone canvassers for conducting surveys, text relays and door-to-door canvassing campaigns

- Assist BCMAC with the development of municipal-level citizen teams on ordinance campaigns (such as petrochemical-protection ordinances, setbacks from industry and solar-friendly ordinances) at municipal meetings and with agencies like the Beaver County Council of Governments (COG)
- Support the BCMAC rapid response team to alert members to educate legislators or attend municipal meetings when needed
