"In the context of air quality, CREATE Lab tries to publicly document pollution that damages all of our health," says Ana Tsuhlares Hoffman, director of air quality engagement for CMU's CREATE Lab. "We try to do right by residents who come to us with concerns about exposure to some of our large industrial emitters, and who often tell us they don't believe they're being heard by the industrial point source emitters or the regulators who are tasked with ensuring industry's compliance with the Clean Air Act as well as our commonwealth's constitution-given rights to clean air and pure water for the benefit of all people."

This marks the fifth time that local residents have stepped up to voice their concerns through a regional resident-led coalition to highlight SWPA's unhealthy air quality. The leadership team includes residents from Clairton, Braddock, Uptown, Hazelwood, Homewood, Squirrel Hill, Shadyside, Bellevue, Northside, Franklin Park and Sewickley.

Our region is in the worst 1% of places to live in America for cancers caused by air pollution. Our youth asthma rate for those living closest to the worst sources of pollution is nearly triple the national average.
